**LGBTQ INCLUSIVE SCHOOLS: GOING DEEPER
THROUGH A CASE STUDY APPROACH**

Audience: Secondary Counselors, Teachers, Administrators who have previously participated in Creating LGBTQ Inclusive Schools, or who have knowledge or experience working with LGBTQ students

Through studying and discussing case studies related to LGBTQ students, families and schools, participants will deepen their understanding of how to effectively include LGBTQ students and their families in their school communities. Problem-solving and small and large group discussions will be embedded in each session. Our goal with the series is to increase the comfort and confidence of each member of the seminar. This growth will come from sharing ideas and reactions and more deeply understanding one's own approach to situations as well as learning from other alternative approaches to daily and "once in a school year" dilemmas that occur in the life of a school.

Presenter: Daisy Boyd-Berks, LCSW

Daisy Boyd-Berks, LCSW is the lead clinician for the ACCEPT Educational Collaborative's Middle School Academy. She is a licensed clinical social worker with a background in education and psychiatric social work. Daisy previously had a private practice in Brooklyn, NY where she specialized in LGBTQ issues as well as maternal mental health. She also served as a school social worker at Brooklyn Prospect Charter School. Daisy worked closely with NYC's LGBTQ Center as a group facilitator and panelist in the area of LGBTQ conception and parenting. All of her work, in and out of the classroom, is built upon a strengths based model of intervention.
